### Purpose:

The Office for People With Developmental Disabilities (OPWDD), through its Developmental Disabilities Regional Offices (DDROs), determines whether a person has a developmental disability, as defined by New York State Mental Hygiene Law, Section 1.03(22), and whether such person is eligible for OPWDD-funded services pursuant to 14 NYCRR §§ 629.1, 629.2.

The purpose of this ADM and its embedded document titled *OPWDD Guidelines for Determining Eligibility for Services: Substantial Handicap and Developmental Disability* (hereinafter "Eligibility Guidelines") is to establish eligibility procedures for people seeking OPWDD services. The Eligibility Guidelines have been updated to incorporate eligibility-related information previously issued by OPWDD into one document. It also includes updated diagnostic terminology to reflect current diagnostic practices.

The Eligibility Guidelines supersede any contradictory guidance issued in previous OPWDD guidance documents.

## Background:

OPWDD determines whether an individual has a developmental disability as defined in MHL 1.03(22) pursuant to Title 14 of the New York Codes, Rules and Regulations sections 629.1 and 629.2. These regulations were adopted on December 19, 2018 (amended insert date), and XXX, XXX, 2022, respectively, in accordance with longstanding OPWDD eligibility determination practices. This ADM, and its embedded Eligibility Guidelines, were created to reflect the eligibility determination process as outlined new regulation and consolidate existing OPWDD eligibility related guidance.

#### **Discussion:**

14 NYCRR § 629.1 establishes OPWDD's eligibility determination process. The Eligibility Guidelines provide guidance on clinical and procedural issues related to the determination and review of basic eligibility for OPWDD supports and services.

#### **Documentation Requirements:**

Documentation requirements are discussed throughout the attached Eligibility Guidelines.

#### **Records Retention:**

Eligibility records must be maintained by the DDRO as part of the individual's clinical record.
